Security

Wherever sensitive information is collected, that information is encrypted and transmitted to us in a secure manner. This can easily be verified by finding the closed lock icon in your browser address bar, or by confirming “HTTPS” precedes our web address.

Only authorized users or employees who need the information in order to perform a specific function such as billing or customer service have access to personally identifiable information. All company computers/servers in which personally identifiable information is stored are housed in a secure location as well.
